



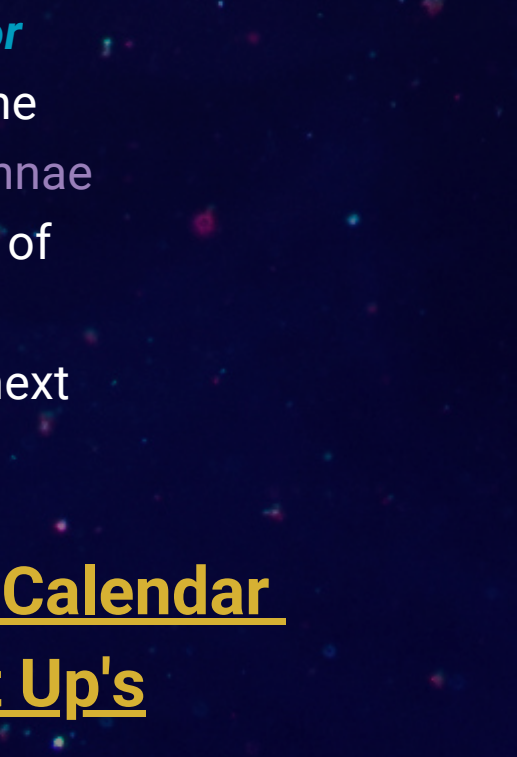

With COVID cases increasing we will be trying to keep you and our Team safe and will be looking to schedule any meetings online.

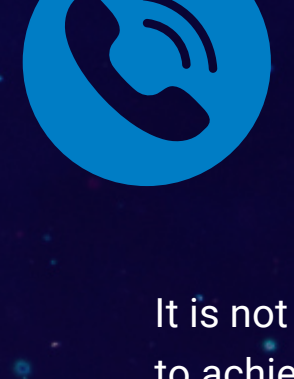

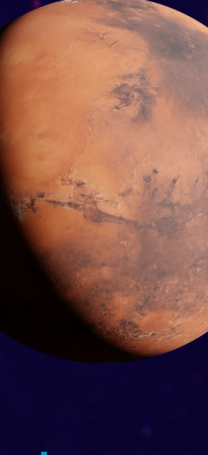

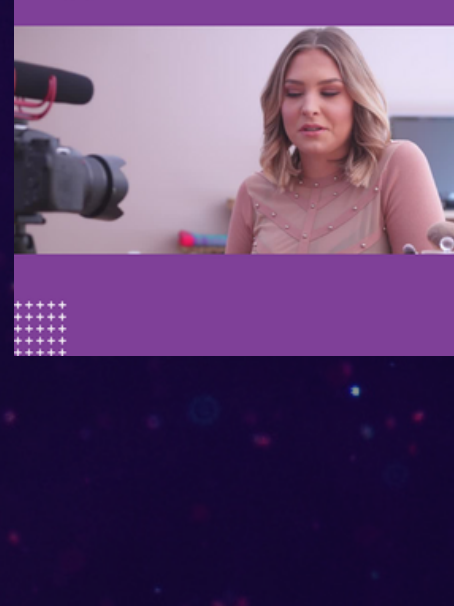

- Payers must issue PAYG withholding payment summaries to payees (that is, employees and other workers).**
 - Lodge and pay June 2022 monthly business activity statement.**
 - The Chasers Meet Up**
 - Lodge and pay quarter 4, 2021–22 activity statement if electing to receive and lodge by paper and not an active STP reporter.**
 - Pay June quarter, 2021–22 instalment notice.**
 - Make super guarantee contributions for quarter 4, 2021–22 to the funds by this date.**
- Employers who do not pay minimum super contributions for quarter 3 by this date must pay the super guarantee charge and lodge a Superannuation guarantee charge statement – quarterly by 28 August 2022.*
- Note:** The super guarantee charge is not tax deductible.

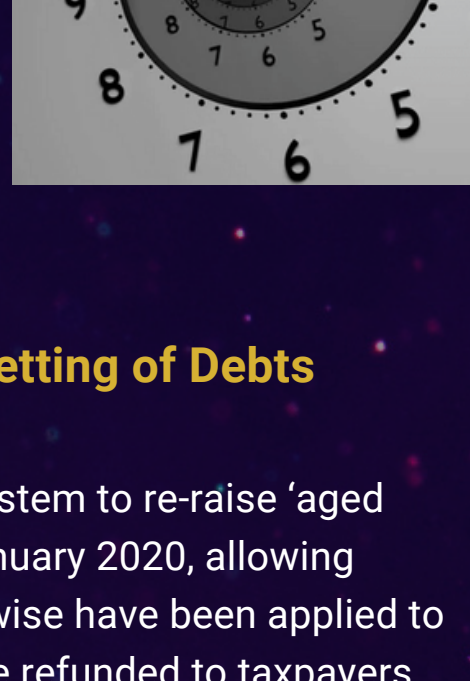

ATO Resuming Offsetting of Debts Previously on Hold!

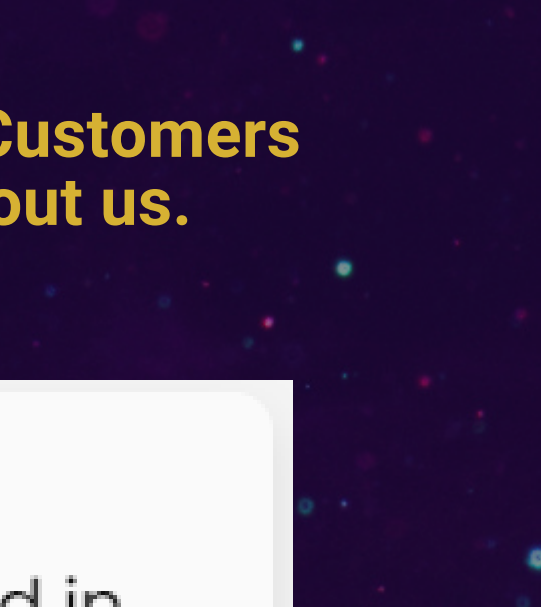


The ATO's automated system to re-raise 'aged debts' was paused in January 2020, allowing credits that would otherwise have been applied to those debts to instead be refunded to taxpayers to assist them through the COVID pandemic. However, the ATO has advised that from June 2022, it will recommence offsetting customers' tax refunds or credits to pay off their debts on hold.
